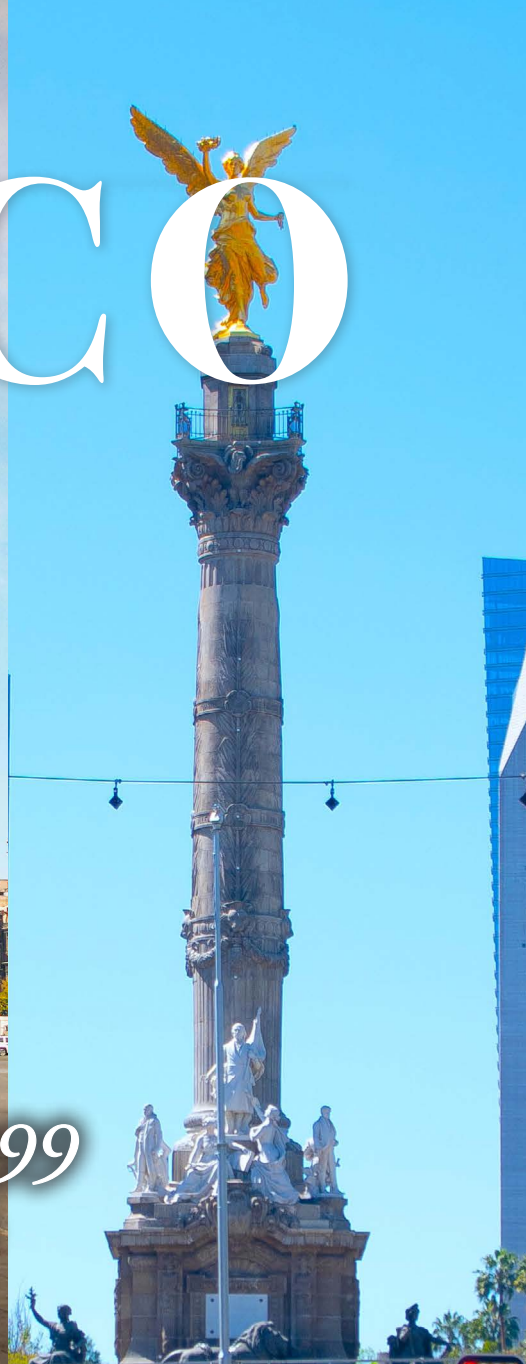

## October 1, 2025

Depart Los Angeles on AM785 at 9:55 AM and arrive in Guadalajara at 2:12 PM. After completing immigration and customs procedures, proceed to the exit door to meet your guide. Transfer to the hotel for dinner and an overnight stay.

## October 2, 2025

### Guadalajara, Zapopan, and Tlaquepaque

Enjoy a tour of downtown Guadalajara, including visits to the Government Palace, Guadalajara Cathedral, Hospicio Cabañas, Liberty Market, and all the main plazas in the city center. Then, travel to Tlaquepaque for lunch and shopping. Return to Guadalajara for dinner and an overnight stay.

## October 3, 2025

### Guanajuato, San Juan De Los Lagos, Cristo Rey

Depart Guadalajara for Guanajuato, with stops in San Juan de los Lagos and Cristo Rey along the way.

## October 4, 2025

### Guanajuato and San Miguel De Allende

Explore Guanajuato City, including La Valenciana Silver Mine and the Church of San Cayetano. Continue to Atotonilco, a small village with a stunning church

dedicated to Jesus of Nazareth. Conclude the day in San Miguel de Allende with a visit to the downtown area and shopping opportunities.

## October 5, 2025

### Querétaro, Tepotztlán, and Mexico City

Spend the morning exploring Querétaro City. In the afternoon, visit the Museum and Convent of Tepotztlán. Continue to Mexico City for dinner and an overnight stay.

## October 6, 2025

### Zócalo Square and National Museum of Anthropology

Visit Zócalo Square, home to the largest cathedral in Latin America, and see the archaeological excavations of the Aztec Templo Mayor. In the afternoon, explore the renowned National Museum of Anthropology.

## October 7, 2025

Drive to the Plaza of the Three Cultures, the Shrine of Guadalupe, and the Teotihuacán Pyramids.

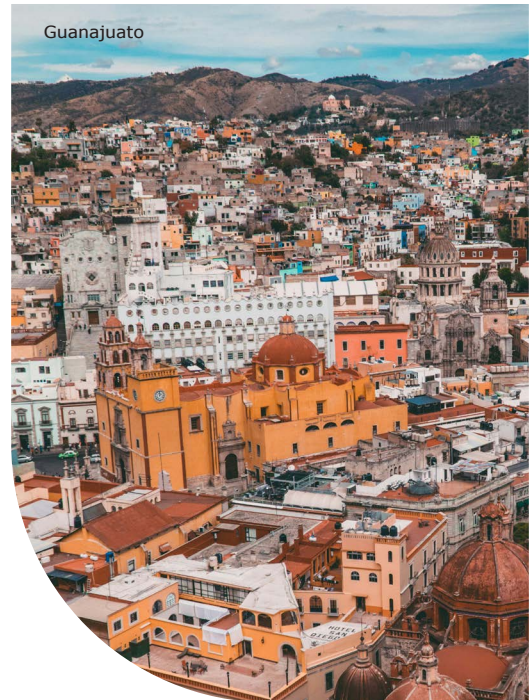

## PAYMENT INFORMATION

**Deposit:** \$350.00 per person is required at the time of registration, Travel Protection is included.
